

General Instructions for B.Ed online Counselling

- 1) Seats are allotted as per merit cum preference choice of candidates.
- 2) 85% of B.Ed seats are reserved for candidates who have passed graduation from university of Jharkhand state.
- 3) 15% of B.Ed seats are open seats.
- 4) For reserved category seats following certificates are required at the time of admission.

- (a) **Reservation on Caste Basis:-** The current reservation policy of Govt. of Jharkhand will be followed for admission in Institutes. Candidates have to submitted caste certificate in proper format, issued by competent authority, at the time of admission. [Circle Officer or Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State]. The caste certificate issued by any other authority and in other than prescribed format will not be entertained for claiming reservation and his/her claim for reservation will be rejected.

As per Letter no. 14/Ja.Ni.-03-13/2015/Ka.-1754 dated 25.02.2019 of Deptt. Of Personnel, Administrative Reforms and Rajbhasha, Govt. of Jharkhand, Candidates belonging to BC – I & BC – II, will have to Submit the caste certificate at the time of admission. Caste certificate produced by BC – I & BC – II Candidates will be valid only if he/she does not belong to creamy layer & it should be mentioned in caste certificate. The Notification copy & caste certificate format is available under **Act & Circulars** column on the Board's website.

- (b) **Reservation for Economically Weaker Sections (EWS):-** Candidates from Economically Weaker Sections can avail benefits of reservation as per Memorandum (Memo No.-14/Aa.Ni.-04-02/2019/Ka.-1434 Dated 15-02-2019) of Personnel, Administrative Reforms and Rajbhasha Department, Ranchi.

Candidates claiming reservation will have to Submit Income & Assets Certificate in proper format, issued by competent authority [Circle Officer or Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State]. The concerned Memorandum and format for the Certificate is uploaded on the Board's Website.

- (c) **Reservation for Person with Disabilities:-** Divyang candidates with locomotory disability of lower limbs can avail benefits of reservation as per letter no.-9/ Namankan-02-05/17-243(9) Dated 09.10.2020) of Health, Medical Education & Family Welfare Department, Ranchi.

Candidates claiming reservation will have to Submit Disability Certificate in proper format, issued by competent authority [Chairman of the Medical Board & Countersigned by Medical Superintendent/Chief Medical Officer/ Head of the Hospital of Jharkhand State].The concerned Memorandum and format of the Certificate is uploaded on the Board's Website.

- (d) **Reservation for Primitive Tribal Groups Candidates :-** Candidates from primitive tribal groups can avail benefits of reservation as per Memorandum (Letter No. 5555 Dated 28.06.2016) of Personnel, Administrative Reforms and Rajbhasha Department, Ranchi. The concerned Memorandum is uploaded on the Board's Website.
